

APPLICATION FOR WATER SERVICE AND WATER USERS' AGREEMENT
RURAL WATER DISTRICT NO. 6, DOUGLAS COUNTY, KS

The undersigned, _____ being the owner or intended owner of the land described below located within the above Rural Water District, hereby submits a \$50.00 deposit and makes an application to said District for water service, and agrees to the following conditions:

- 1) The deposit hereby submitted is non-refundable if this application for water service is not approved by the Board of Directors.

If after service is approved, applicant agrees to the following:

- 2) Purchase or cause to be purchased one benefit unit at the unit price of \$ _____ less the deposit for the balance due of \$ _____.
- 3) Pay for all costs to extend pipeline from the District's existing facilities to the location of service.
- 4) Failure to pay balance due for the benefit unit within 30 days from date of meter installation and/or approval shall constitute a cancellation of this approval for water service, and forfeiture of the \$50.00 deposit.
- 5) Begin paying the minimum monthly base charge of \$24.00 thirty days from the date the benefit unit is approved by the District, and pay for additional water used at the rate set out in the rate schedule adopted by the Board of Directors. Any changes made in the minimum shall become a part of this agreement as though fully set out herein.
- 6) The undersigned agrees to pay for any damage to the districts assets installed on the tract described below. The undersigned agrees to not make any physical connection or arrangement in their piping system whereby there may be a flow of any unknown or harmful substance into the District's water supply system. The undersigned agrees to not make any physical connection between any private water system and the water system of the physical connection between any private water system and the water system of the District Representatives of the District may at any reasonable time come on the premises where the water is being used for the purpose of making inspection to enforce this provision and other purposes necessary perform the duties of the District. Violation of this provision shall be grounds for disconnection of service.
- 7) The laws of the state of Kansas, the Bylaws of the District, and the Rules and Regulations of the District as presently exist in an as may be amended from time to time, are made a part of this agreement as though fully set out herein.
